

IMPORTANT INSTRUCTIONS

1. Mop-up counselling will be held on 20.11.2025 at 9:00 AM in all the private affiliated colleges/institutes. All private colleges/institutes shall widely publicise the vacant seats before making admission and will strictly follow the merit list of VLDD- 2025. The counselling schedule will be uploaded by the concerned affiliated college/institute on the college/institute website.
2. The Dean/Principal, of the concerned affiliated college/institute, as Chairman will form an Admission Committee.
3. Those candidates who have already taken admission in IPVS, LUVAS, Hisar or any other Private Affiliated Colleges/Institutes will not be eligible for mop-up counselling. If such candidate wants to participate in mop-up counselling, then he/she has to cancel his/her admission, and he/she has to submit a request in the O/o Director, IPVS, LUVAS, Hisar at least one day prior (i.e. 19.11.2025 up to 03:00 pm) to mop-up counselling, failing which he/she will not be allowed to participate in mop-up counselling.
4. In mop-up counselling, the candidates who have cancelled their admission have to pay fresh fees again in the respective colleges/institutes and the previous fee will be refunded as per university rules.
5. **The reserved seats for any category will be filled-up before the mop-up counselling on 20.11.2025 by candidates of the same category upto 11:00 am and in case, if the seats still remain vacant in any category, then those will be filled by converting the same as per rules mentioned in the prospectus 2025-26. This will be done on the spot in the same mop-up counselling after 11:00 am.**
6. Colleges/Institutes will maintain attendance register and signature of candidate with time and date on the day of counselling. **The colleges/institutes will inform the applicants to carry their original documents as well as application form on the day of counselling.**
7. In case of two or more candidates scoring the same marks in the VLDD-2025 for VLDD, the merit among these candidates will be decided on the basis of percentage of aggregate marks obtained in 10+2 examination. If still, there is a tie, then the merit among these candidates will be decided on the basis of percentage of marks obtained in Matriculation examination. If still, there is a tie, then the candidate senior in age will be considered higher in the merit.
8. The Haryana resident candidates will be considered first for admission and the other state candidates (eligible only for management quota seats) will be considered thereafter for admission to management quota seats based on the

marks obtained in VLDDDET-2025.

9. The State quota seats if remain vacant will be converted to Management quota after due announcements in Mop-up counselling to be held on 20.11.2025.
10. The affiliated private colleges/institutes will submit the list of candidates enrolled in their respective college institutes in prescribed format (given below) by 24.11.2025 along with all original documents along with one set of photocopies of all documents being self- attested by the candidate.
